NEW GOLF VENUE

The prestigious Ridgewood Country Club is regarded as one of the top golf courses in the world according to *Golf Magazine*. Founded in 1890, the club is listed by the U.S. Golf Association as one of the first 100 golf clubs established in the U.S. Aside from its rich history, its twenty-seven-hole course is a masterpiece designed by A.W. Tillinghast, who also planned Winged Foot and Baltusrol. Ridgewood is considered a PGA Championship site and has hosted The Northern Trust PGA Tour four times with notable golfers like Hunter Mahan, Vijay Singh, and Tiger Woods playing the challenging course.

ABOUT THE CHILDREN'S CARDIOMYOPATHY FOUNDATION

The Children's Cardiomyopathy Foundation (CCF) is a national nonprofit dedicated to finding causes and cures for pediatric cardiomyopathy, a chronic and potentially life-threatening heart disease.

The Foundation started in 2002 with one family's determination to call attention to a poorly understood disease and to take action on the lack of medical progress and public awareness. Seventeen years later, CCF has grown into a global community of families, physicians and scientists focused on improving diagnosis, treatment and quality of life for children with cardiomyopathy.

Proceeds from the Golf for a Cure event will go towards CCF's research programs in partnership with the American Heart Association, American Academy of Pediatrics, and North America Pediatric Cardiomyopathy Registry. More than 305 medical publications and presentations have resulted from CCF-funded initiatives, which has led to improved guidelines for physicians treating children with cardiomyopathy.
